PRIVACY POLICY

INTRODUCTION

The ISPP List is an e-mail list server which broadcasts messages and announcements to its subscribers. Its goal is to facilitate communication among members of the International Society for Plant Pathology and its Associated Societies. Advertised vacancies in plant pathology and ISPP Newsletter alerts are also sent to members of the ISPP List.

In accordance with the guidelines and recommendations established by the new EU General Data Protection Regulation 679/2016 (GDPR), the International Society for Plant Pathology has created a Privacy Information Notice containing all the information you need to know about how we collect, use and protect your personal data.

This policy explains when and why we collect personal information about our users, how we use it, the conditions under which we may disclose it to third parties, how we keep it safe and secure and your rights and choices in relation to your personal information.

Data Controller

The ISPP ("us", "we", or "our") operates https://www.isppweb.org (the "Site"). This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site.

We use your Personal Information only for providing and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy.

INFORMATION COLLECTION AND USE

While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to your name ("Personal Information").

LOG DATA

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data").

This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics.

In addition, we may use third party services such as Google Analytics that collect, monitor and analyze this data.

COOKIES

Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.

Like many sites, we use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Site.

COMMUNICATIONS

We may use your Personal Information to contact you with our <u>Newsletter</u>, marketing or promotional materials.

THE ISPP NEWSLETTER

We use to send our subscribers a regular monthly newsletter. To do this, we collect the following personal data: First Name, Last Name, email address. We use Mailchimp.com to provide our service to the subscribers. The registration form is easily reachable in our Site: Join ISPP List Form.

NATURE OF DATA PROVISION

The provision of data is optional but necessary to provide the service. Refusal to provide the same will not allow provision of the service.

SECURITY

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage, is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

The above data is never permanently saved on the device. The user can delete it at any time using the functions present in all our communications.

The data will be processed in Italy.

RIGHTS OF DATA SUBJECTS
